## (A)ELIGIBILITY

(1) Educational Qualifications For the Teacher Posts

<u>Desirable Qualification as per UGC Regulations</u> [Maharashtra Agricultural Universities (Krishi Vidyapeeths) (First Amendment) Statutes, 2014]:

(i) Ph. D. in relevant/ concerned subject as per the post advertised from an Indian University, or an equivalent degree from an accredited foreign university.

Or

Master's degree in Physical Education/Masters degree in Yoga from an accredited Indian University, Or an equivalent degree from an accredited foreign university along with National Eligibility Test (NET) conducted by Indian Council of Agriculture Research (ICAR)/University Grants Commission (UGC)/Council of Scientific and Industrial Research (CSIR) or similar test accredited by the University Grants Commission (UGC) like State Level Eligibility Test (SLET)/ State Eligibility Test (SET).

Or

Bachelor degree in Ayurvedic Medicine and Surgery (BAMS)

Additional Qualification:

- 1. Diploma in Yoga
- 2. Professional degree in Yoga

## (B) Work Experience:

The candidate with relevant work experience and additional qualifications if any as stated above as per the nature of post will be given preference.

### (C) Nature of Work:

The selected candidate has to conduct one UG course entitled "Physical Education, First aid and Yoga Practices" to be offered in Third Semester of B.Sc (Hons.) Horticulture Degree Programme along with related academic work such as conducting midterm, semester end theory and practical examinations, setting of question and model answer papers, evaluation of answer paper, preparation of results, maintaining records of student attendance as per the guidelines of Associate Dean, College of Horticulture, Mulde.

This course is of 0+2 credits having Two Credits for practical and One credit is equivalent to 2 clock hrs. This college has two batches each having 30 students. This means total 8 hrs are to be taught by the teacher in a week.

## (D) AGE LIMIT:

Candidates should not exceed 60 years on scheduled date of interview.

## (E) Procedure for Application:

- i. Applicants satisfying the above eligibility shall submit their hard copy of the application at the time of interview to **Associate Dean**, **College of Horticulture**, **Mulde** covering all the points in the prescribed proforma enclosed herewith for application on plain A-4 size paper only.
